# MEMBERSHIP APPLICATION

## MEMBERSHIP AGREEMENT

- 1) I have submitted a written application with the current Membership fee. \$40.00 Set-Up fees (set up web page on **TB<sup>3</sup>** web site) and \$30.00 for your 1<sup>st</sup> Quarter Membership Dues = Total of \$70.00 (*Credit Cards Accepted Only when paying Annual dues*)
- 2) I understand that if I fail to make payment in full by the due date that my category is open and available for a new member and that I will not be listed in the new **TB<sup>3</sup>** Membership Directory for that quarter.

  - d. Any breach of confidentiality.
  - e. Failure to comply with all By Laws, Code of Ethics, Policies and Procedures as written
